6. All vendors shall exhibit professional manners always, this includes appropriate attire. (No short shorts and no crop tops allowed)
7. Spaces shall be assigned by the Summerfest Chairperson.
8. Vendor is responsible for bringing their own canopy, tables and extension cords provided they need electricity.
9. Applicable fees shall be paid before date of show.
10. Only one vendor company per table/space
11. Collected fees go towards advertising, maintenance, and other items as decided upon by Queen of the Holy Rosary School Committee.
